Minutes of the Board of Education in regular session March 14, 2011.

- Quorum** A regular meeting of the Board of Education Houston R-I School District of Texas County, Missouri was convened at 6:00 pm. with the following members present: Kathleen Hutcheson, Steve Pounds, Jo Holland, Doug Castleman, Sharon Horbyk, and Tom Dunn. Darrell Scheets arrived at 6:42 p.m.
- Approve Agenda** A motion was made by Steve Pounds and seconded by Doug Castleman to approve the agenda as amended to include Summer School. Motion carried 6-0.
- Recognition** Amy Dill recognized Reese Bucher, Mike Anderson, and Dennis Wilson for donating money to 1st and 2nd grade to attend the Shrine Circus in Springfield.
- OTC Presentation** Members of the Ozark Technical College Steering Committee gave information to the board of the progress to bring OTC to Houston. The committee asked the board to vote to put a fifteen cent tax levy on a future election ballot. The School Boards of all the other school districts in Texas County are also being asked to place the issue on their ballots. If approved by voters, funds from the levy will go directly to OTC and would not be connected to the Houston school district.
